Newspaper Articles

The references below are from newspapers that were archived on microfilm decades ago. In recent years the microfilm has been digitized and made available online by various organizations, usually as a paid subscription service. Use any of these online newspaper archives to find the referenced articles with the information given below. Occasionally an article not found in one online archive can be found in a different one. In some instances the same story is referenced more than once here, in different newspapers. This has been done because the print quality in many early newspapers is poor and the old microfilm images are not the best, either. Something that may not be readable in one paper, may be more easily read in the same article in a different paper.

The articles are listed chronologically below. On this web page you can also search by key word(s). Type Ctrl F then enter your search string in the search box and use the forward and back arrows to look for additional occurrences of the key word(s). Dates are given as yyyy-mm-dd. The code at the end of each entry tells the page and column number where the article is found in the paper. A hyphen after a page number indicates that the page number is not printed on the original newspaper page.

Municipal Ordinances

Albuquerque 1910 Municipal Ordinance 432 required licensing of motor vehicles operated within the City of Albuquerque. License number had to be displayed on vehicle but no mention was made as to who supplied plate.

Las Vegas Automobile licensing ordinance No. 349, effective August 13, 1910. Required automobiles and motorcycles in Las Vegas to be licensed and to display of a single license plate to be supplied by the City Clerk.

Santa Fe City Municipal Ordinance Section 279, effective November 11, 1910. Required that motor vehicles operated within the city of Santa Fe be licensed and owner to display license number on vehicle at his own expense.

Raton Ordinance No. 169, effective February 7, 1911. Required the licensing of motor vehicles operated within that city and display of license number, but made no mention of who supplied plate.

State Laws

1912 Laws of New Mexico, Chapter 28. First state licensing law. Required licensing of automobiles only, and issuance of license plates.

1912 Laws of New Mexico, Chapter 28, Sec. 3. Directs license fees to go into the State Road Fund.

1913 Laws of New Mexico, Chapter 19. Motor vehicle licensing law. Requires all motor vehicles, not just automobiles, to be licensed. Created Dealer category. Changed expiration date for licenses issued in 1912 and 1913 to December 31, 1913. Prohibited municipalities from requiring an additional license for motor vehicles.

1915 Laws of New Mexico. Mostly a reiteration of the 1913 law.

1917 Laws of New Mexico, Chapter 11. Created De Baca County.

1917 Laws of New Mexico, Chapter 23. Created Lea County.

1917 Laws of New Mexico. Chapter 38, Section 15. Created State Highway Commission. Defines "State Road Fund," wherein certain taxes and registration fees are deposited.

1917 Laws of New Mexico, Chapter 61. Fire insurance companies authorized to insure motor vehicles.

1917 Laws of New Mexico, Chapter 65, Article II, Sec. 16. Mechanics shall have a lien upon motor vehicles for repairing and storing such motor vehicles.

1917 Laws of New Mexico, Chapter 66. Unauthorized / unlawful taking of automobiles, bicycles, motorcycles, and other vehicles.

1919 Laws of New Mexico, Chapter 11. Created Hidalgo County.

1919 Laws of New Mexico, Chapter 150. Note, this is an extensive and detailed motor vehicle law that addresses many more aspects of the regulation of motor vehicles than those indicated in the following few references to it.

1919 Laws of New Mexico, Chapter 150, Section 1. Defined Motor Trucks and specified higher registration fees for them.

1919 Laws of New Mexico, Chapter 150, Section 9. Established multi-year license plates which were implemented as New Mexico's porcelain plates.

1921 Laws of New Mexico, Chapter 27. Repeals Sec. 31 of Chapter 150, Laws of 1919, regarding heavy vehicles with narrow tires.

1921 Laws of New Mexico, Chapter 28. Created Catron County.

1921 Laws of New Mexico, Chapter 48. Created Harding County.

1921 Laws of New Mexico, Chapter 94. Regarding brakes, lights, signals, lugs and cleats, on motor vehicles. Regulating traffic on public highways.

1923 Laws of New Mexico, Chapter 96, Sec. 1. Changed definition of "motor truck" from a solid tire truck to "Any motor vehicle designed and used principally for carrying things other than passengers."

1923 Laws of New Mexico, Chapter 96, Sec. 3. Set forth new commercial categories and higher fees for them, unique license plates. Omitted requirement for Dealer plates to have the word "DEALER." Required trailers to be licensed.

1923 Laws of New Mexico, Chapter 96, Sec. 5. Required plates for commercial vehicles, trailers, etc., to show the weight and carrying capacity.

1923 Laws of New Mexico, Chapter 96, Sec. 10. Exempted federally owned vehicles from having to pay for New Mexico registration.

1925 Laws of New Mexico, Chapter 82, § 5. Defined "motor vehicle" to mean motor vehicle and trailer subject to the payment of registration fees under the laws of New Mexico.

1925 Laws of New Mexico, Chapter 82, Section 6. Required county assessors were to prepare automobile assessment rolls. Forms provided by the Motor Vehicle Department to the county treasurers to be used as receipt showing proof of payment of the property tax before vehicle could be registered.

1927 Laws of New Mexico, Chapter 28. Gave municipalities the authority to license drivers.

1927 Laws of New Mexico, Chapter 111. State Comptroller shall collect and distribute Motor Vehicle registration fees.

1929 Laws of New Mexico, Chapter 75, § 54. Established brake & light safety inspections and provided for the issuance of certificate of inspection to be issued upon completion of inspection.

1929 Laws of New Mexico, Chapter 119. Note: This is an extensive and detailed motor vehicle law that addresses many more aspects of the regulation of motor vehicles than those indicated in the following references to it.

1929 Laws of New Mexico, Chapter 119, § 1. Defining buses, taxicabs, driverless cars, semi-trailers, etc., and licensing thereof.

1929 Laws of New Mexico, Chapter 119, § 15. No longer requires trailer plates to show weight and carrying capacity.

1929 Laws of New Mexico, Chapter 119, § 19(a). Explicitly said that either the word "DEALER or a distinguishing symbol" could be used on Dealer plates.

1929 Laws of New Mexico, Chapter 119, § 28. Changed basis for registration fees from horsepower to vehicle weight. Raised registration fee penalty for solid tire vehicles from 25% to 100%.

1929 Laws of New Mexico, Chapter 119, § 32. Lifted double taxation of motor vehicles by prohibiting property tax on duly licensed vehicles.

1929 Laws of New Mexico, Chapter 121. Note, this is an extensive and detailed motor vehicle law that addresses many more aspects of the regulation of motor vehicles than those indicated in the following reference to it.

1929 Laws of New Mexico, Chapter 121, § 51/2 [sic]. Required registration certificates to be display in a special holder provided by the state.

1931 Laws of New Mexico, Chapter 30. Exemption of fees for trailers under 1 ton used by farmers.

1931 Laws of New Mexico, Chapter 32. Inspection of brakes and lights

1931 Laws of New Mexico, Chapter 33. Regulating the weight of vehicles and loads.

1931 Laws of New Mexico, Chapter 77. Amends prior laws governing motor vehicles, sets registration expiration date as December 31 of each year, registration fees, lost number plates (license plates), motor truck registration fees, taxicab and driverless car registration fees, 100% surcharge on registration fees for vehicles using solid tires other than rubber, distribution of fees.

1931 Laws of New Mexico, Chapter 162. \$10,000 appropriation for purchase of license plates, and other monies allocated for Motor Vehicle Department.

1933 Laws of New Mexico, Chapter 5. Authorized the State Penitentiary to manufacture New Mexico's license plates and road signs, authorized \$15,000 to buy necessary equipment, and required the State Comptroller and State Highway Department to buy all their license plates and road signs from the prison.

1933 Laws of New Mexico, Chapter 12. Amended prior laws regarding motor vehicle registration cards.

1933 Laws of New Mexico, Chapter 24. Sale of license plates and other items manufactured by the State Penitentiary restricted to departments of the State of New Mexico.

1933 Laws of New Mexico, Chapter 61. Regulated hours of service of drivers and chauffeurs of motor vehicles for hire.

1933 Laws of New Mexico, Chapter 69. Amended prior laws with respect to motor vehicle registration fees.

1933 Laws of New Mexico, Chapter 79. Authorized creation of New Mexico Motor Patrol (renamed New Mexico State Police in 1935.)

1933 Laws of New Mexico, Chapter 100. Assigns care, control, supervision and custody of all state-owned vehicles to the State Highway Engineer.

1933 Laws of New Mexico, Chapter 118. Amends prior laws with respect to speed, weight, size, and loads of motor vehicles on New Mexico highways.

1933 Laws of New Mexico, Chapter 139. Amends prior laws with respect to registration fees.

1933 Laws of New Mexico, Chapter 154. Regulation of motor vehicles for hire, common carriers, contract motor carriers, private motor carriers, fees and taxes, etc.

1933 Laws of New Mexico, Chapter 169. Amends prior laws defining vehicle types, legal owner, registered owner, and regarding registration cards and transfer of registration, fees for registration of automobiles, motorcycles, trailers, semi-trailers, motor trucks, taxicabs, driverless cars, surcharge for solid tires; inspection of lights, brakes and steering equipment, etc.

1933 Laws of New Mexico, Chapter 186. \$10,000 appropriation for purchase of license plates, and other monies allocated for Motor Vehicle Department.

1935 Laws of New Mexico, Chapter 9. Created Bureau of Revenue. Placed the Comptroller's office and, hence, the Motor Vehicle Department, within the Bureau of Revenue.

1935 Laws of New Mexico, Chapter 15. Owner or operator of motor vehicle not liable for injury, death, or loss by non-paying passenger unless intentional or caused by heedlessness or recklessness disregard of the rights of others.

1935 Laws of New Mexico, Chapter 56, Section 1(c). Required out-of-state salesmen to buy license plate for \$5.00. Required out-of-state companies regularly operating any motor vehicle, trailer or semi-trailer within New Mexico to register each such vehicle and pay the fees. Other fees, including for dealers and special permits..

1935 Laws of New Mexico, Chapter 75. Motor trucks required to be equipped with flares for use when truck is stopped on or adjacent to highway at night. Must be visible from 500 feet.

1935 Laws of New Mexico, Chapter 119. Changed the name of the New Mexico Motor Patrol to the New Mexico State Police.

1935 Laws of New Mexico, Chapter 151. \$10,000 appropriation for purchase of license plates, and other monies allocated for Motor Vehicle Department.

1937 Laws of New Mexico, Chapter 110. Required for the first time that drivers and chauffeurs have state-issued licenses.

1937 Laws of New Mexico, Chapter 120. Provided that a special license plate be provided to salesmen.

1937 Laws of New Mexico, Chapter 135. Motor trucks cannot be registered or licensed until required number of flares are shown.

1937 Laws of New Mexico, Chapter 137. Regulating out-of-state dealers of used motor vehicles.

1937 Laws of New Mexico, Chapter 196. Certain motor vehicles carrying property or passengers must have clearance, identification and side marker lamps.

1937 Laws of New Mexico, Chapter 224. Amending prior laws concerning regulation of motor vehicle for hire, common carriers, etc.

1939 Laws of New Mexico, Chapter 9. Established Bureau of Revenue.

1939 Laws of New Mexico, Chapter 20. Provided for lower registration fees for school buses operated by private companies.

1939 Laws of New Mexico, Chapter 79. Establishing certain school bus zones and regulations for other drivers within those zones.

1939 Laws of New Mexico, Chapter 101. Vehicle registration still expires December 31, but deadline for renewal is now March 2.

1939 Laws of New Mexico, Chapter 117, Section 1 (d). Eliminated the requirement that out-of-state salesmen buy New Mexico license plates.

1939 Laws of New Mexico, Chapter 156. Amended the 1937 law on drivers and chauffeur licenses, including raising the minimum age for school bus drivers from 17 to 21.

1941 Laws of New Mexico, Chapter 11. No vehicle to be transported on highways either on its own wheels or on another vehicle unless vehicle is licensed by New Mexico, is owned by a license dealer, or a special permit is obtained for the transportation of such vehicle.

1941 Laws of New Mexico, Chapter 87. Dealers shall remove foreign license plates that are on motor vehicles to which they acquire title.

1941 Laws of New Mexico, Chapter 140. Providing for issuance of certificates of title by the motor vehicle department. Requirements pertaining to transfer of title, etc. Title and registration plates to be surrendered for wrecked vehicles.

1941 Laws of New Mexico, Chapter 149. Established Mounted Patrol.

1941 Laws of New Mexico, Chapter 199. Regulation of traffic on highways. Providing for traffic signs and signals. Certain safety equipment to be used on motor vehicles. Defining power of local authorities to enact or enforce ordinance related to matters within this law.

1941 Laws of New Mexico, Chapter 212. Motor Vehicle Division of Bureau of Revenue to receive 6% of all motor vehicle registration fees for its operations and expenses.

1943 Laws of New Mexico, Chapter 35. Regulating size and weight of vehicles operated on public highways. Permits for excessive size and/or weight.

1943 Laws of New Mexico, Chapter 39. Military personnel may operate out-of-state vehicles without New Mexico registration or license for six months for duration of hostilities between U.S. and axis powers.

1943 Laws of New Mexico, Chapter 54. Chauffeur licenses, School bus drivers must be 17 or older

1943 Laws of New Mexico, Chapter 73. Providing for issuance of certificates of title. Transfer of title requires turning in to the motor vehicle department both the old title and old registration certificate.

1943 Laws of New Mexico, Chapter 127. Motor Vehicle Division of Bureau of Revenue to receive 6% of all motor vehicle registration fees for its operations and expenses.

1945 Laws of New Mexico, Chapter 40. Provided for optional license periods of one, two, or three years for chauffeur licenses vs. previous one year license.

1945 Laws of New Mexico, Chapter 32. Illegal to dump scrapped automobiles (junkers) on highways or rights of way.

1945 Laws of New Mexico, Chapter 42. Certain persons not to be granted operator's or chauffeur's licenses. Persons at least 17 years of age may be licensed to drive school busses for the duration of the present war.

1945 Laws of New Mexico, Chapter 139. Motor Vehicle Division of Bureau of Revenue to receive 6% of all motor vehicle registration fees for its operations and expenses.

1947 Laws of New Mexico, Chapter 15. Prohibited Staff Officer plates and any other similar designations not authorized by law on number plates.

1947 Laws of New Mexico, Chapter 56. Reciprocal agreements. Established Reciprocity Commission.

1947 Laws of New Mexico, Chapter 144. Amended prior laws governing certificates of title, liens, registration by tourists, vehicles used for agricultural purposes, non-residents engaged in business in the state, transportation of cars on highways by dealers, etc.

1947 Laws of New Mexico, Chapter 171. Busses and trucks carrying passengers shall not be heated by any stove with an open flame.

1947 Laws of New Mexico, Chapter 221. Motor Vehicle Division of Bureau of Revenue to receive 6% of all motor vehicle registration fees for its operations and expenses.

1949 Laws of New Mexico, Chapter 134. Created Los Alamos County.

1949 Laws of New Mexico, Chapter 141. When title is transferred, registration must be transferred and number plates (license plates) must be left on the vehicle.

1949 Laws of New Mexico, Chapter 163. Reciprocal agreements between New Mexico and other states to exempt motor vehicles from registration and fees for vehicles from those states which reciprocate by exempting New Mexico motor vehicles for registration and fees.

1949 Laws of New Mexico, Chapter 179. Motor Vehicle Division of Bureau of Revenue to receive 6% of all motor vehicle registration fees for its operations and expenses.

1951 Laws of New Mexico, Chapter 42. Fees for registration of motor vehicles.

1951 Laws of New Mexico, Chapter 170. Chauffeur and Driver Licenses and fees.

1953 Laws of New Mexico, Chapter 74. Chauffeur Licenses - certain persons prohibited.

1953 Laws of New Mexico, Chapter 91. Authorized Amateur Radio plates.

1953 Laws of New Mexico, Chapter 128. 1953 Laws Chapter 128 - Out of state chauffeur licensees can drive but not chauffeur in state.

1953 Laws of New Mexico, Chapter 138. Pertaining to Bus, Taxi, House Trailer, etc.

1953 Laws of New Mexico, Chapter 138, Sec. 77. Provided the basis for the issuance of Dealer Manufacturer and Wrecker plates.

1953 Laws of New Mexico, Chapter 138, Sec. 24. Establishing Division of Motor Vehicles within Bureau of Revenue.

1953 Laws of New Mexico, Chapter 138, Sec. 51. Mandated two license plates. Specified appearance of license plates.

1953 Laws of New Mexico, Chapter 140. Distribution of Drivers license fees.

1955 Laws of New Mexico, Chapter 11. Authorized special plates for U.S. Representatives and U.S. Senators from New Mexico.

1955 Laws of New Mexico, Chapter 16, Sec. 1. Amendments to laws regarding certificates of title.

1955 Laws of New Mexico, Chapter 19, Sec. 1(d). Exemption of trailers from licensing if use only for transport of farm produce and animals.

1955 Laws of New Mexico, Chapter 37. Size and weight limitations for motor vehicles and their loads.

1955 Laws of New Mexico, Chapter 113. Explicitly authorized State Representative and State Senator license plates which identified the vehicle owners as such.

1955 Laws of New Mexico, Chapter 158. Authorizes schools to provide driver education.

1955 Laws of New Mexico, Chapter 179. Made operator (driver) licenses good for two years, with expiration on birth date instead of December 31. Chauffeur badges reverted to one year period with expiration on December 31. Person holding chauffeur license need not obtain an operator license; Instruction (learner's) permit.

1955 Laws of New Mexico, Chapter 183, Sec. 2. Temporary licenses (permits) for motor vehicles.

1955 Laws of New Mexico, Chapter 183, Sec. 10. Fees for titles, registration certificates, dismantling permits, liens, etc.

1955 Laws of New Mexico, Chapter 247, Sec. 3. Excise tax on certificates of title.

1955 Laws of New Mexico, Chapter 276. Reciprocal agreements, proportional registration.

1957 Laws of New Mexico, Chapter 207. Exempting payment of excise tax on certificates of title under certain circumstances.

1957 Laws of New Mexico, Chapter 236. Registration fees for motor vehicles.

1959 Laws of New Mexico, Chapter 3. Registration fees for trucks, and farm & ranch vehicles; Temporary plates.

1959 Laws of New Mexico, Chapter 151. Permitting voluntary inclusion of blood type on operators' and chauffeurs' licenses.

1959 Laws of New Mexico, Chapter 155. Special callsign license plates for Amateur Radio and commercial radio/television stations, and employees of the latter. Explicitly stated the purpose of these plates for both Amateur Radio and commercial radio.

1959 Laws of New Mexico, Chapter 156. Motor vehicle registration by non-residents.

1959 Laws of New Mexico, Chapter 157. Reduced fees for registration for portion of a year; 30-day Seasonal Agricultural Permits for vehicles owned by persons engaged in migrant seasonal labor.

1959 Laws of New Mexico, Chapter 158. Special license plates for State Representatives, State Senators, Chief Clerk of the House and Senate, Mounted Patrol.

1959 Laws of New Mexico, Chapter 161. Exemption of veteran amputees from payment of registration fees.

1959 Laws of New Mexico, Chapter 236. Regulation of transportation of passengers or property for hire.

1959 Laws of New Mexico, Chapter 247. Permits for oversize and overweight loads.

1959 Laws of New Mexico, Chapter 338. New Mexico Boat Act. Required statewide licensing of boats for the first time.

1961 Laws of New Mexico, Chapter 51. Vehicles on loan from dealers and used in Driver Education programs at public schools need not be registered but must display plates provided by the Motor Vehicle Division. [Probably the DE plates.]; The Division is to issue plates for vehicles and trailers in the service of the state, counties, and municipalities. These shall be permanent plates, numbered to identify the state division/department, county, or municipality to which issued.

1961 Laws of New Mexico, Chapter 95. A motor vehicle is considered validly registered if the owner is in possession of a current certificate of registration and there is displayed on the vehicle one or more plates issued by the DMV, even if the plate(s) do not meet the requirements of the Laws of 1953, Chapter 138, Sec. 51. [This law was enacted to eliminate confusion caused by the recent switch from two plates to one plate, which Governor Mechem claimed was "unconstitutional."]

1961 Laws of New Mexico, Chapter 109. Dealers and wreckers of vehicles must procure a corporate security bond before being licensed.

1961 Laws of New Mexico, Chapter 124. Prorated fees for portion of the year; 30-day agricultural permit for persons engaged in seasonal agricultural employment; two-day Drive Out permit for nonresidents purchasing a vehicle for transport out of the state.

1961 Laws of New Mexico, Chapter 180. New plates for the coming year must not be displayed before December 15; House Trailers must bear current registration plates. [Plates were required in 1955, but not 1956-1960.]

1961 Laws of New Mexico, Chapter 194. Terms of operator's and chauffeur's licenses; Fees increased for chauffeur licenses.

1962 Laws of New Mexico, Chapter 3. Single plate legitimacy extended to March 2, 1964.

1963 Laws of New Mexico, Chapter 15. No permit or fee is required for farm tractors or implements to travel on highways during daylight hours for a one-way distance of 50 miles or less.

1963 Laws of New Mexico, Chapter 30. Front seat belts required on automobiles beginning with 1964 models.

1963 Laws of New Mexico, Chapter 41. Boat dealers exempted from requirement that dealers and wreckers of vehicles post a bond.

1963 Laws of New Mexico, Chapter 51. Authorized Horseless Carriage plates for automobiles at least 35 years old. Explicitly stipulated that plate was to be undated, Trucks were not eligible, and that plate was to be renewed every 5 years. [Trucks were added by 1973 Laws, Chapter 5.]

1963 Laws of New Mexico - Chapter 70 - Pertaining to motor vehicle employees - Handling of fees.

1963 Laws of New Mexico, Chapter 84. The Division of Motor Vehicles shall issue to the owner of a registered vehicle a plate, or plates, or decals [stickers], annually designated by the Commissioner of the Division of Motor Vehicles.

1963 Laws of New Mexico, Chapter 125. The name of the Division of Motor Vehicles is changed to the Department of Motor Vehicles, and the department is established within the Executive branch.

1963 Laws of New Mexico, Chapter 170. Establishment of Reciprocity Commission.

1963 Laws of New Mexico, Chapter 171. Authorizes transfer of plates from one vehicle to another vehicle owned by the same person, for a fee of \$10.00.

1963 Laws of New Mexico, Chapter 174. Established the Pro-rate Truck and Pro-rate Trailer categories, and license plates of this type. Registrations; Titles; Proportional registration; Interstate operation; Reciprocity Commission.

1963 Laws of New Mexico, Chapter 322. Excise tax on issuance of certificates of title.

1965 Laws of New Mexico, Chapter 17. Reduced annual registration fees for school buses.

1965 Laws of New Mexico, Chapter 47. Authorized issuance of temporary permits pending issuance of registration and certificate of title by the motor vehicle division.

1965 Laws of New Mexico, Chapter 99. Provided for the issuance of single-trip permits for school buses.

1965 Laws of New Mexico, Chapter 140. Amended the definition of "motor vehicle" to include boats and airplanes.

1965 Laws of New Mexico, Chapter 148. Authorized special plates for the Sergeant at Arms of both the House and the Senate.

1966 Laws of New Mexico, Chapter 65. Required the licensing of billboards, with the New Mexico State Highway Department/Commission as the licensing authority.

1967 Laws of New Mexico, Chapter 65. Authorized issuance of special personalized prestige license plates (vanity plates). Fee is \$25. Applicant must reapply each year, but has first priority on plate held the previous year.

1967 Laws of New Mexico, Chapter 97. Created Department of Motor Transportation. Department to establish Ports of Entry. Commercial Motor carriers required to register with the Department.

1967 Laws of New Mexico, Chapter 105. Authorized limited driver's licenses for certain visually impaired persons.

1967 Laws of New Mexico, Chapter 108. Special registration fees for buses with seating capacity of 40 persons or less used exclusively for transportation of agricultural workers. Exempted Agricultural Buses from the tariff-filing requirements of the State Corporation Commission.

1967 Laws of New Mexico, Chapter 191. Persons 13 years of age or older may be licensed to operate motor scooter of 5 brake horsepower or less. Helmets required for persons operating motorcycles, motor scooters, etc.

1967 Laws of New Mexico, Chapter 251. Any owner who sells a motor vehicle for scrap or dismantling must transfer title to the buyer.

1967 Laws of New Mexico, Chapter 263. Veterans temporarily exempt from having driver's license under certain limited circumstances.

1967 Laws of New Mexico, Chapter 264. Authorized special "Auxiliary Police" license plates for members of the Bernalillo County Citizens Unit (BCCU).

1967 Laws of New Mexico, Chapter 301. Driver's licenses to include photograph of licensee. Photos for persons over 21 years of age to be full face front view; For persons under 21 years to be profile side view.

1968 Laws of New Mexico, Chapter 2. Special registration fee for liquid fertilizer trailers.

1968 Laws of New Mexico, Chapter 29. Established requirement for periodic safety inspection and issuance of safety (brake & light) stickers for motor vehicles, including trailers, semi-trailers and pole trailers. Inspections to be at least twice a year but not more than three times per year.

1968 Laws of New Mexico, Chapter 60. Nonresident persons engaged in full-time study at institutions of higher learning not required to register their vehicles in New Mexico.

1969 Laws of New Mexico, Chapter 21. Fee for personalized prestige (vanity) plate reduced from \$25 to \$15.

1969 Laws of New Mexico, Chapter 30. Persons driving in New Mexico are deemed to have given implied consent to breath or blood test to determine blood alcohol content.

1969 Laws of New Mexico, Chapter 70, Sec. C.(1). Nonresident persons engaged in full-time study at institutions of higher learning not required to register their vehicles in New Mexico, but must display a nonresident student student student from institution. Sticker to be provided to institution by Department of Mother Vehicles.

1969 Laws of New Mexico, Chapter 70, Sec. C.(2). Nonresidents commuting daily to work in New Mexico and returning to home outside New Mexico not required to register vehicle in New Mexico. Applies only if home state provides reciprocal privilege to New Mexico residents.

1969 Laws of New Mexico, Chapter 107. Fees for registration of trailers, semi-trailers, house trailers, house trailers. Trailers used for transporting agricultural products and animals are exempt.

1969 Laws of New Mexico, Chapter 169, Sec. 8. Occupying a house trailer while it is being towed is prohibited. Towing an occupied house trailer is prohibited.

1969 Laws of New Mexico, Chapter 266. Driver's licenses, chauffeur licenses, temporary licenses, instruction permits. Helmets, eye protection, for motorcyclists. Motorcycle handlebars may not be higher than 15 inches above the top of the seat when the seat is fully depressed.

1970 Laws of New Mexico, Chapter 50. Requires aircraft hangared or based in New Mexico to be registered, and registration fees paid. Fees are: One year old or less, two cents per pound of manufacturer's stated gross weight; Two years old, \$0.0175 per pound; Three years old, \$0.015 per pound; four years old, \$0.0125 per pound; Five years or more old, \$0.01 per pound.

1970 Laws of New Mexico, Chapter 59. Inspection of air pollution control equipment in certain motor vehicles.

1970 Laws of New Mexico, Chapter 74. Fees for operator's (driver's) licenses.

1971 Laws of New Mexico, Chapter 37, Sec. 1.C.(1). Right turn on red light now permitted.

1971 Laws of New Mexico, Chapter 38. Established a system of staggered registration, for passenger vehicles only, whereby each registrant was arbitrarily assigned to a specific registration period. The initial registration period shall not be more than seventeen months, with registration fees prorated accordingly. The MVD shall determine the number of vehicles to be assigned to each staggered registration period, in order to initiate the system not later than January 1, 1973. Registration for all other vehicle shall expire on December 31 and must be renewed by March 2. (Approved March 2, 1971.) NOTE: This system was never implemented, but a simpler system whereby the registration period was based on the month of the vehicle's initial registration was authorized by the 1981 Laws of New Mexico, Chapter 361, and implemented effective April 1, 1982.

1971 Laws of New Mexico, Chapter 39. Lists revised registration fees for passenger vehicles.

1971 Laws of New Mexico, Chapter 177. Registration of snowmobiles and fees therefor. Upon receipt of the registration certificate the owner must affix or paint the full registration number on both sides of the forward half of the snowmobile.

1971 Laws of New Mexico, Chapter 255. Regulation of Special Permits for oversize loads.

1971 Laws of New Mexico, Chapter 279. Provides definitions of motorcycle, motor-driven cycle, and motor scooter, and the regulation thereof.

1972 Laws of New Mexico, Chapter 7. Provided for the issuance of Freight Trailer license plates. Registration fees for trucks, truck-tractors, road tractors, buses, trailers, freight trailers, semi-trailers, pole trailers.

1972 Laws of New Mexico, Chapter 15. Authorized special plates for "members of the consular or diplomatic corps of a foreign country who are certified by the United States Department of State."

1972 Laws of New Mexico, Chapter 27. Established the Recreational Vehicle (RV) category and the issuance of special RV stickers for 1974 plates, and purpose-made RV plates beginning 1975.

1972 Laws of New Mexico, Chapter 35. Change of registration fees for taxicabs.

1972 Laws of New Mexico, Chapter 86, effective Jan. 1, 1973. Established Mobile Home category for license plates. Registration and taxation of house trailers. Special Permits for movement of house trailers.

1973 Laws of New Mexico, Chapter 5. Authorized trucks to be registered as horseless carriages [in addition to automobiles, which were authorized in 1963].

1973 Laws of New Mexico, Chapter 19. Required name of county in which plates were issued to be shown on plates, effective January 1, 1977, for all plates issued in 1977 and thereafter. [This was facilitated by the county name sticker box that was introduced in 1977.]

1973 Laws of New Mexico, Chapter 20. Established minimum sizes for motor vehicles permitted on highways, including minimum wheelbase of 3' 4", and minimum motor displacement of 45 cc.

1973 Laws of New Mexico, Chapter 22. Authorized special handicap plates for disabled persons.

1973 Laws of New Mexico, Chapter 27, Sec. 1.D. Revised Laws of 1972, Chapter 86, regarding Mobile Home licensing.

1973 Laws of New Mexico, Chapter 30. Changed the definitions of certain types of trailers and changed the provisions for registration of certain types of trailers.

1973 Laws of New Mexico, Chapter 176. Prohibits motor vehicles from having windows or window coverings that prevent viewing from the exterior into the interior of the vehicle.

1973 Laws of New Mexico, Chapter 269. Authorized the Department of Motor Vehicles to issue identification cards to persons sixteen years of age or older who do not have an operator's (driver's) license.

1973 Laws of New Mexico, Chapter 389. Required reflectorized license plate to be issued once every six years, beginning in 1977. A fee of 50 cents per plate to be imposed once every six years, coinciding with the issuance of the reflectorized plates.

1975 Laws of New Mexico, Chapter 35. Pertaining to the preservation of certain motor vehicles of historical and special significance. Exempts such vehicles from modern safety and emissions requirements.

1975 Laws of New Mexico, Chapter 42. Amendments to registration and licensing of snowmobiles.

1975 Laws of New Mexico, Chapter 60. When so requested by the licensee, permits driver's licenses to indicate that the licensee is an organ donor.

1975 Laws of New Mexico, Chapter 162. Directs DMV to issue plates with reflective background. Reflective material to have durability to last for six years. Plates to be issued once every six years, validated by stickers annually. Plates to display (1) the registration number, (2) the name of the state, centered across the bottom of the plate, (3) the year for which it was issued, (4) the name of the county across the top of the plate. Requirements to be effective with plates issued in 1977 and thereafter. [Note that the law did not require the plate to carry the Land of Enchantment slogan, and in fact six weeks after passage of the law the Director of the MVD said that the slogan would be dropped to make room for everything else that was required, though in the end that did not happen.]

1975 Laws of New Mexico, Chapter 209. Issuance of titles and non-negotiable certificates of title.

1975 Laws of New Mexico, Chapter 240. Off Highway Motorcycle Act. Sets requirements for registration and titling, including registration fees. Dealers must obtain a dealder demonstration certificate for each vehicle used for demonstration.

1975 Laws of New Mexico, Chapter 271. Provides for a separate license for operators of motorcycles.

1976 Laws of New Mexico, Chapter 36 (passed by the Special Session of the 32nd Legislature). Imposition of excise tax on certificates of title for certain vehicles, but persons on active military duty and domiciled outside of the state are exempt.

1977 Laws of New Mexico, Chapter 5. Persons under the age of 18 operating or riding on motorcycles required to wear an approved safety helmet.

1977 Laws of New Mexico, Chapter 60. Changes requirements for registration of motor vehicles by nonresidents.

1977 Laws of New Mexico, Chapter 93. Repealing certain sections of the motor vehicle inspection law.

1977 Laws of New Mexico, Chapter 100. Definition of terms relating to motor vehicles.

1977 Laws of New Mexico, Chapter 135. Motorized bicycles. Definition of. Licensing requirements for operators. None of the provisions of the Motor Vehicle Code applicable to motor vehicles apply to motorized bicycles, except the provisions of this law.

1977 Laws of New Mexico, Chapter 210. Amendments to law regarding registration and certificate of title.

No attempt has been made to summarize it here except for the one item immediately below.

1979 Laws of New Mexico, Chapter 299. Authorizes special plates to be made available to veterans who were one hundred percent disabled by an enemy of the United States during an armed conflict.

1979 Laws of New Mexico, Chapter 329. Specifies persons to whom driver's and chauffeur licenses are not to be issued.

Permits permanent registration for freight trailers for \$10.00; States annual registration fees for utility trailers; Provides for five-year fleet registration for owners of fifty or more utility trailers, with registration fees paid annually for all trailers in fleet.

1979 Laws of New Mexico, Chapter 375. Authorizes special plates to be made available to former Prisoners of War, at no charge.

1980 Laws of New Mexico, Chapter 44. Eliminates fees for special plates for 100% disabled veterans, members of the N.M. Mounted Patrol and members of the N.M. Rangers.

1980 Laws of New Mexico, Chapter 45. Makes available special plates for members of the National Guard, at no extra fee.

1980 Laws of New Mexico, Chapter 61. Increased fees for oversize / overweight permits.

1981 Laws of New Mexico, Chapter 361. Note: This is an extensive and wide ranging motor vehicle law which runs 46 pages. Only a very few of its many provisions are cited below.

The License Plate Book, 1991 edition, by Thomson Murray, edited by Michael Weiner. Rather than photographs, illustrations are line drawings rather than photographs, similar to those in MVD publications of the 1970s and 1980s. On p. 72, shows passenger plate KAK-001 reinstating "USA" on plates.

Publications of the Automobile License Plate Collectors Association (ALPCA)

Since its inception in 1954 ALPCA has produced an in-house publication for its members. Originally just a few loose mimeographed pages, by the early 1970s it had evolved into a true magazine format under the name *ALPCA Newsletter*. This title was used through 1999, changing to *ALPCA Register* at the beginning of 2000, continuing through October 2004. The current name, *PLATES*, appeared with the December 2004 issue. Published somewhat irregularly the first eight years, the magazine became a regular bi-monthly in 1962, a publication frequency which continues to the present day.

Aside from the appearance of several feature-length articles on New Mexico plates over the decades, a "Notes from the States" column was introduced in the mid-1970s and has appeared in every issue since. The "Notes" column reports the latest available news of interest from all the states and Canadian provinces, though there is not news to report from every jurisdiction in every issue. For New Mexico, these items are considered generally reliable, as most of them came from local newspaper articles, or from former New Mexico Department of Motor Vehicles employee Michael Wiener. Most, but not all, of the New Mexico articles and "Notes" items carried by the magazine are cited below.

"Plate Impressions, Land of Enchantment adds New Varieties, June 1981, p.60, Michael C. Wiener. A report on numerous new plate types introduced during the previous several years. "Notes from the States" news items:

- 1976 April Stickers for 1976 are red, white and blue, with the American flag.
- 1976 June More than 4,500 of the 1976 Bicentennial vanity plates have been sold to date.
- 1977 February Description of new dies introduced in October 1976; new format with USA eliminated; debossed border; county name sticker box; 1977 vanities are turquoise on white; general reissue in December 1977; will change from plate-to-car, to plate-to-owner, provided legislature approves.
- 1977 April Handicap (wheelchair) vanities now being issued; Transition from last old style plate BTM-999 to first new style plate BTN-001; New truck plates begin CA-5001; Passenger series plates CAA-001 CBZ-999 have been manufactured.
- 1977 June General reissue planned for December will not occur, as legislature did not approve; 1978 Vanities will be red on yellow.
- 1977 December Now issuing third type of passenger plate on 1972 base; All passenger plates will be red on yellow (vs. red on white) beginning with CEA-001 (but see next item).
- 1978 February New red-on-yellow plates began with CCX-001, not CEA-001; Cost of manufacturing plates has increased; SAM-PLE plates in new colors are available for \$3 each.
- 1978 April Next general issue now delayed until 1980 registration year; Ex-Prisoner of War and Medal of Honor plates to be issued; legislation permitting motorcycle vanity plates has passed both houses.
- 1978 December First four Medal of Honor plates have been issued; More than 200 Ex-Prisoner of War plates have been issued; Vanity plates for 1979 will be yellow on blue.
- 1979 December Disabled Veteran plates are now being issued, according to the *Albuquerque Journal*.
- 1980 April Recent riots at New Mexico State Penitentiary did not damage plate manufacturing plant; National Guard plates were approved by the recent legislative session.
- 1980 December National Guard plates are now being issued in the format 123-ANG, where ANG signifies Army National Guard; Plates of the format RT-1234 are being issued to rental cars (but this information was wrong, as RT plates were for rental *trailers*); Vanity plates for 1981 will be red on yellow.
- 1981 April A bill has been introduced in legislature to authorize special plates for retired National Guard members; Current passenger serial numbers have exhausted AAA DZZ and now will start E prefix; M prefix serial numbers for motorcycles are exhausted, will now switch to N prefix; 1981 stickers are green on white.
- **1982** April New plates with taller and thinner dies will be issued beginning April 1, 1982, Passengers will start EHA-001, trucks will start GE-0001; Sticker box will be larger to accommodate the new staggered registration stickers.

1983 June – Stickers for 1983 are white on red.

1983 December – Stickers for 1984 are white on blue.

- 1984 April The position of the year and month have swapped places on the white-on-green 1985 stickers.
- 1984 June A bill was introduced to authorize Purple Heart plates, but did not make it through the 1984 legislative session.
- **1985 June** 1986 stickers are white on black.
- 1986 June Albuquerque newspapers report that City Councilor Michael Wiener is urging law enforcement to crack down on person driving with expired license plates.
- **1986 October** Michael Wiener has been appointed by Governor Tony Anaya to head a committee to design an official front plate commemorating the 75th anniversary of statehood.
- **1987 August** Stickers for 1988 are white on brown.
- 1990 June A complete reissue of all plates will be accomplished between January 1991 and December 1993. The new plates will have a southwestern design, which since became to be known as the "yucca" plate. The first 200,000 will be made of steel, then a switch will be made to aluminum. Numbering format will be 123-ABC; Pearl Harbor Survivor plates are now on the road in small numbers; Collegiate plates have been approved by the legislature, but none have yet been manufactured.
- **1991 February** Last October the MVD determined that there would not be sufficient passenger car plates for the two months remaining in the year before the new graphic plates in the 001-AAA format were to be introduced. Consequently, 21,000 of the new graphic plates were made and issued in the old format from LKM-001 through LLL-999.
- 1993 October Children's Trust Fund ("Kids") plates may soon be available. A bill introduced by State Senator Michael Wiener would prohibit the use of license plate frames on the state's plates because they obscure part of the information thereon.
- 1993 December The bill authorizing the Children's Trust Fund plates was signed into law by Gov. King; All of the old exempt plates, e.g., HD, OF, XM, XC, will be replaced by the end of this year with the new "G" prefix state Government plates; New black-on-grey State Police plates manufactured in Texas are being issued to all State Police vehicles.
- 1994 June The new Children's Trust Fund ("Kids") plates are now being seen on New Mexico's roads.
- 1997 December Some passenger plates in the "K" series are being seen on Trailer bases, i.e., without the yucca and Land of Enchantment slogan. This was thought to be an error, but see the item below.
- **1998 February** The passenger plates in the "K" series was not an error, but was done intentionally because of running out of the regular graphic sheeting for passenger plates. Approximately 40,000 plates in the KFH through KHM series were made with the trailer base sheeting.
- **1998 June** Lawmakers are considering legislation to eliminate most metal Dealer plates and replace them with cardboard plates. More than 20,000 Dealer plates are presently in use. (Note: this plan was ultimately put into place, eliminating all but a tiny number of metal Dealer plates. Vehicles now use paper "Demonstration" plates in their stead.)
- **1998 December** A leaky roof at the prison plate plant caused an electrical hazard necessitating shutdown of the facility from July 7 to August 9 of this year. During this period 42,000 New Mexico plates were manufactured in Arizona, some of them without the Zia symbol.
- 1999 February The hot air balloon plate will soon be available. As of January 2, 1999 New Mexico motorists have the option of selecting either a one-year or a two-year registration period.
- 1999 June All New Mexico plates are now being manufactured at Waldale in Amherst, Nova Scotia, Canada. Waldale won the contract with a bid of \$1.235 per plate, delivered, beating out the State Prison's bid of \$1.37. The design continues as before, beginning at 001-MAA, with the only difference being dies that are 3/8" shorter. The State Penitentiary ran out of plates twice since June 1997, most recently in July 1998 when the state had to have 44,000 plates made at the Arizona, differing only in the shape of the bolt holes, those from Arizona having round holes. The optional regular issue balloon license plate went on sale April 30, 1999.
- **1999** August The serial numbering system for the new balloon plates is explained.
- **1999 December** Over 100,000 balloon plates have now been issued, with serial numbers now switched to a more conventional 3-letter, 3-numeral configuration, beginning with CAA-001. There are complaints about the plates being hard to read, especially at night. Collegiate plates are now available, but no mention is made of which universities the plates are available.
- 2004 August The Share With Wildlife plate is now available, featuring a picture of a Gambel's quail.
- 2006 February The New Mexico State University (NMSU) plate has been redesigned, with a description given. Initial cost is \$37.
- 2006 June The Donate Life (Organ Donor) plate was expected to be available last month.
- 2006 October The state's current administration is considering a return to two license plates. (But this did not occur.) The Pet Care plate, also called the Spay-Neuter plate, is now available, some three years after it was authorized by the legislature.
- 2007 April The Support Our Troops plates have been available since September 11, 2006.
- 2007 August The Route 66 plate is now available.
- 2008 February New Mexico's new State Government plate is illustrated.
- **2008 June** A plate promoting the city of Las Cruces will soon be available, but only to residents of that city.

2008 December – The Breast Cancer Awareness plate is now available.

2009 June – The city of Las Cruces plates mentioned in this column a year ago were expected to finally be available in April of this year.

- **2009 October** A new optional turquoise statehood centennial plate will become available in January 2010, replacing the balloon plate. The yellow yucca plate will continue to be available. State law effective July 1, 2009 authorizes a special Gold Star license plate for certain close relatives of persons killed in the line of military duty.
- 2009 December A survey of 9,000 persons found that 75% want the option of choosing whether to receive a yellow yucca plate or a turquoise centennial plate. The city of Las Cruces plates are finally available.
- 2010 April Collegiate plates for Eastern New Mexico University and the New Mexico Military Academy are now available.
- 2010 August Three more optional plates have become available: New Mexico Highlands University, Boy Scouts, and Adoption Awareness.
- 2010 December An optional Bass Fishing plate, officially known as "Fish New Mexico," is available.
- 2011 February The Farm and Ranch Heritage plate became available on an optional basis on December 20, 2010.
- 2014 April Approximately 28,600 personalized "vanity" plates are currently in use.
- **2015 February** A Purple Heart motorcycle plate is now available to qualified veterans.
- 2015 April Lawmakers are looking at the possibility of authorizing some 15 optional "heritage" plates featuring designs that symbolize the heritage of the state of New Mexico, including cities, professions, wildlife, and so forth.
- 2016 June The Share With Wildlife plate now has a picture of a mule deer on it, replacing the Gambel's quail.
- 2016 October The centennial slogan has been removed from the turquoise plates, as it is no longer timely. Not mentioned is the fact that the slogan remains on turquoise motorcycle plates. (And in fact, still remains on them in 2020.)
- 2017 April A chile plate is now under consideration by the state legislature.
- 2017 June New Mexico's chile plate has beat out a plan by Colorado to usurp the title of "Chile Capital of the World" by issuing a similar plate. The chile plates are now one of three optional regular issue plates available to New Mexico motorists without charge beyond the usual registration fees.
- 2017 October 20,000 of the new chile plates (which were released on July 10, 2017) were sold during the first month of their availability. Numbering started at AAAA00.
- 2017 December License plates on New Mexico State Police vehicles are in the process of being replaced for the first time in ten years, using a new design featuring the NMSP uniform shoulder patch. A motorcycle version of the new plates is being issued as well.
- 2018 April The state legislature is again considering switching back to having two plates on each vehicle, a system abandoned by the state 58 years ago.
- 2020 February The University of New Mexico collegiate plates have been redesigned.
